CRUSHING SALVAGED CONCRETE AND ASPHALT

GENERAL PROVISIONS TO THE SPECIFICATIONS

INTENT:

The intent of these specifications is to describe crushing salvaged concrete and asphalt in Yankton, South Dakota. The work described in this contract shall consist of crushing approximately 25,000 to 35,000 tons of salvaged concrete and asphalt road material (refer to the *Detailed Specification Section* for explanation of total quantity).

COMPOSITION OF THE BID:

The bid price shall include all labor, equipment and services required to fully and properly complete the specified work.

The prices quoted on the bid schedule shall be firm and shall be the total price as stipulated above.

BID FORMS:

All bidders must use the forms provided by the City of Yankton.

Bidders must submit completed bid proposal forms in a sealed envelope or packet clearly marked on the outside: "CRUSHING SALVAGED CONCRETE AND ASPHALT".

Additional specifications and bid proposal forms may be obtained at the Office of the Public Works Manager, P.O. Box 176, Yankton, South Dakota, 57078 or by phoning (605) 668-5211.

BID CLARIFICATION:

Bidders may contact the Public Works Manager (605) 668-5211 for additional clarification of these specifications.

Request for such clarification should reach the Public Works Manager no later than seven (7) days before the date on which bids are due.

Prior to submission of bids, any ambiguities in the specifications shall be brought to the attention of the Public Works Manager. If necessary, an addendum will be issued to give effect to such clarification.

INSURANCE

Contractor shall furnish affidavit of a minimum of \$300,000.00 public liability and property damage insurance and worker's compensation insurance statutory for the State of South Dakota.

NONDISCRIMINATION:

The Contractor shall not discriminate against persons on the grounds of race, color, or national origin and must comply with the Code of Federal Regulations, Title 49, Part 21, "Nondiscrimination Federally

Assisted Programs of the Department of Transportation - Effectuation of Title VI of the Civil Rights Act of 1964".

TAXATION:

The City of Yankton shall be exempt from all Federal or State and local taxation. The City shall not be liable for additional payment to defer the cost of any tax or other imposition that might be made by Federal or State taxing authorities.

PAYMENT

Payment under this contract shall be cash upon the submittal of a billing statement and acceptance by the City Commission of the City of Yankton in accordance with the following policy.

It is the policy of the City of Yankton to approve all bills on the 2nd Monday of each month and mail checks on the following Thursday. Therefore, all requests for payment must be received by the City of Yankton by the 25th day of each month in order to process the request on the regularly scheduled payment date. Should the request for payment be made after the date specified payment will not be made until the following month.

CRUSHING SALVAGED CONCRETE AND ASPHALT

DETAILED SPECIFICATIONS

WORKSITE:

The City of Yankton has salvaged concrete, asphalt and binder material stockpiled on City owned property located at 23rd Street and Kellen Gross Drive in Yankton, South Dakota.

SCOPE OF WORK:

Work will consist of crushing approximately 25,000 to 35,000,000 tons (refer to *Details #1, #2 and #3*) of salvaged concrete and asphalt road materials.

Detail #1 The City of Yankton requires a suitable and consistent crushed material for its road construction needs. Therefore, if for any reason, when approximately 4,000 tons have been crushed and the final product of this operation fails to be suitable, the City of Yankton reserves the right to discontinue the operation under the direction of the Public Works Manager. Final payment will be based on the bidder's original unit price for the actual number of tons crushed.

Detail #2 If however, when approximately 4,000 tons have been crushed and the final product is suitable and consistent as specifications set forth and required by the City of Yankton, the Contractor under the direction of the Public Works Manager will crush an additional 21,000 tons to 46,000 tons. Final payment will be based on the bidder's original unit price for the actual number of tons crushed.

Detail #3 Only one bid price will be allowed on this bid form.

MATERIAL CRUSHING:

Contractor shall crush salvaged concrete and asphalt material to a maximum size of 1 1/8-inch.

During the crushing operation, material removed from the stockpile of salvaged concrete, asphalt and binder material shall be blended before entering crusher in such a way as to produce a suitable and consistent crushed material as a final product.

All material shall pass through a magnetic system to remove 90% to 100% of metallic materials.

The material shall be stockpiled at this location with a stacker conveyor. No equipment of any kind will be allowed on the final product stockpile.

QUALITY CONTROL:

The City will hire a certified lab to test material gradation in accordance with South Dakota Department of Transportation Standard Specifications and testing procedures with the City of Yankton modified during process. The certified lab will perform periodic testing during the crushing operation of final product under direction from the Public Works Manager.

BASE COURSE SPECIFICATIONS:

Material is to meet the gradation outlined below (based on South Dakota Department of Transportation (SDDOT) ABC gradation with the exception of 1 1/8-inch size allowance).

METHOD OF MEASUREMENT:

Crushed concrete and asphalt material will be measured in tons (2,000 lbs.) to the nearest tenth of a ton produced. In lieu of the contractor moving in a scale, the material can be weighed by a conveyor scale calibrated on-site.
